This Agreement is made by Sandhills Dog Training LLC of West End, North Carolina and the client whose signature is below.

TRAINING AGREEMENT

- 1** Training will be provided at a rate of \$ _____ for _____ sessions. Payment is due at the start of the first session and refunds will not be given if I choose not to complete all sessions.
- 2** I (the "Client") represent that I am the legal owner of the dog, that the dog has not been exposed to distemper, rabies or parvovirus within the past thirty (30) days, that the dogs' vaccinations are current, and that the dog is properly licensed (if applicable).
- 3** I understand and agree that Sandhills Dog Training LLC reserves the right to terminate this Agreement at any time and fully refund my money without any further liability or obligation to me.
- 4** I understand that my participation and involvement between training sessions is a key part of accomplishing the agreed-upon goals and objectives.
- 5** I assume sole responsibility for the behavior of the dog and forever release, hold harmless, and indemnify Sandhills Dog Training LLC, its officers, employees, trainers, and other agents, from any harm or damage caused by me or my dog to any person or persons or property at any time.
- 6** Furthermore, I expressly and irrevocably forever waive and relinquish any and all claims against Sandhills Dog Training LLC except those arising from gross negligence on the part of Sandhills Dog Training LLC. I understand that Sandhills Dog Training LLC is in no way responsible for the behavior of my dog during or after training.
- 7** If at any time during the training Sandhills Dog Training LLC reasonably believes that the dog is ill, abused, exhibiting aggressive, fearful, compulsive, anxious, phobic, or any behaviors that may interfere or endanger the health and safety of any participants or bystanders, including the dog, I agree that Sandhills Dog Training LLC may unilaterally end any training session.
- 8** I acknowledge that dog bites must be reported to the local authorities as provided by law.
- 9** I will reimburse Sandhills Dog Training LLC for any and all personal injury and/or property damage caused by my dog while being trained by Sandhills Dog Training LLC within five (5) business days of receipt of proof of such expenses. If I do not, I also agree to pay the maximum interest allowed by law and Sandhills Dog Training LLC's reasonable collections and attorneys' fees.
- 10** Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party of this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration and reasonable attorney's fees of the prevailing party.
- 11** This agreement represents the entire understanding between Sandhills Dog Training LLC and me and supersedes any prior written or oral agreements. This contract can only be modified in a written document signed by both parties.
